Royce, an MBA graduate of Georgetown University, graduated with honors Beta Gamma Sigma in International Business.

She oversaw the Presidentially-appointed Fulbright Foreign Scholarship Board and the Presidentially-appointed Cultural Property Advisory Committee – CPAC. The Academy of Women Entrepreneur’s (AWE) was created and launched in 80 countries by Ms. Royce. Assistant Secretary Royce held a Top Secret (TSI) clearance. She was also a full-time university professor at California State Polytechnic University, Pomona and is the recipient of the Distinguished Alumni Award and has served as commencement speaker.
